PRESIDENT'S REPORT, VALDENE BUCKLEY, MCIP

reetings and Happy World Town Planning Day! Parallel with President Obama, I have reached my first anniversary as President of the Institute. The year has flown by and while we may not have been involved in something as big as a reform of the US health care system or been exposed to as many public opinion surveys, we have had our share of accomplishments (as you can see in other sections of the Annual Report) and I have good things to report on the 'State of the Union' at MPPI.

By far the greatest accomplishment of the year was the commitment to establish a student scholarship at the University of Manitoba for City Planning students. Your Council has decided to use most of the proceeds from the 2008 CIP/MPPI Conference to support student education and research and grow our profession.

Recently CIP issued a membership survey regarding services and products of the Institute. Thank you to all those who participated as it is always beneficial to have feedback from current active and retired members. Results of the survey show that the general satisfaction rating is relatively low for a membership-based organization of this nature, meaning that the membership has a relatively high level of indifference to the Institute.

The survey asked members how important a service is to how well CIP is performing. The largest expectation gaps were in the areas of: advocacy on behalf of the profession, professional development

courses and the certification process. Framework Partners, the measurement company, indicates that these are in the "death quadrant" where failure to deal with these issues has impacts on the sustainability of the organization.

Other groups of questions related to the motivation for being a member versus loyalty and general satisfaction. Members who are seen as info seekers, networkers, altruists and retirees are more highly satisfied whereas career launchers, those required to be members, international members and the value driven are less satisfied. In terms of member satisfaction with groups of CIP products and services, CIP performs best in areas that are core to its mandate \sim designations, conferences, awards, publications and underperforms in continuous professional learning, internships and professional development opportunities, events and membership affinity programs.

CIP took these results under consideration as it proceeded to develop a strategic plan over the past year. You will find more detail about that process in the report from our representative on National Council. CIP realizes that it needs to change to stay relevant, to create pride in its membership and to provide value. The affiliates need to line up behind CIP and its new strategic plan which will be focusing more on advocacy, development of new products and services and partnerships. CIP's goal is to be the leading advocate for urban policy and community building across Canada.

In keeping with the direction coming out of National Council and concerns voiced by our members, I see our efforts over the next several years concentrating on:

- Policy and position papers ("Call to Action") ~ being an advocate and voice on planning issues
- Increasing CPL opportunities ~ formal and informal
- Work with CIP on a government relations plan at the Federal, Provincial and local levels

- Partner with other organizations to provide public information/education on planning ~ Heart & Stroke Foundation, NRCan, etc.
- Provide CPL opportunities ~ CIP Climate Change course (November 2010 AGM), LEED ND and Green Buildings, OPPI Project Management course (on-line)
- Improve our website as a service to members and to the public about planning
- Financial stability ~ continue to build our membership base to support programs (e.g., move Provisionals into full membership by sponsoring an exam writing course, and recruit more student members)
- Modernize and streamline our by-law ~ keep our house in order

At the same time, however, we want to have fun and continue to sponsor social events like the golf tournament, our Mix and Mingles and maybe branching into other types of gatherings \sim gala fundraising banquet to support the scholarship fund, (family?) BBQ/picnic, hot dog day.

To support this agenda, membership fees are being modestly increased as per Council policy consistent with the rate of inflation (2.4%, 2008) once again this year. Budget planning is already underway for next year. We are pleased to announce that membership numbers are on the rise and we have now reached almost 140 strong. You will see in the Treasurer's Report that membership fees make up a large part of our revenues and a strong membership base will support our programs.

Lastly, I would like to thank all those volunteers who have committed their time to our initiatives over the past year, especially Council and all its Committee members. Special thanks go out to Maggie Bonnetta and Darcy Fisher from MALA for coordinating the golf tournament, the Manitoba Planning Conference Organizing Committee and the various people who have participated on juries and standing committees (you will see a list of volunteers in this Report \sim we apologize if we have missed any one). Also, a very special thank you to Kari MacKinnon, our Executive Director, who has been our constant, has held us together and has been my support.

Thank you for the honour of allowing me to serve as your President in this, my inaugural year. I look forward to the slate of programs and improvements we propose to make over the next year.





- In March 2008 MPPI Council approved the motion that all revenue raising events be priced to turn a modest profit.
- Administrator came on board in March 2008.
- CIP Conference in Winnipeg yielded better than forecasted revenues. MPPI's share is \$21,142 plus repayment of \$12,000 seed money.
- 2008 Golf Tournament total profit after expenses was \$3735.69. Fifty percent was shared with MALA, leaving MPPI with a profit of \$1867.85. The payment to MALA was given in 2009 and is reflected in the 2009 budget.
- Printing & Supplies: MPPI approved the purchase of a LCD projector for use at events.
- In 2009/10 award funding will be restructured to allocate more funding toward the scholarship.

NATIONAL REPRESENTATIVE'S REPORT, GERRY COUTURE, FCIP

As Past President of MPPI, it was my privilege to represent our Institute on the National Council of the Canadian Institute of Planners over the 2008-09 period. Over the past year, National Council convened the following meetings:

November 28, 2008 conference call
January 23-25, 2009 Vancouver
February 25, 2009 conference call
April 3-5, 2009 Ottawa
May 13, 2009 conference call
June 5-7, 2009 Merrickville (Ottawa)
July 10, 2009 conference call

September 30, 2009 Niagara Falls (CIP Conference) October 3, 2009 Niagara Falls (CIP Conference)

Among a number of initiatives and accomplishments in areas of governance, membership, member services, academic and student affairs, national affairs, and international affairs, here are a few highlights:

New Strategic Plan

A new 10-30 year strategic plan was developed and adopted. The BAG (Big Audacious Goal) is described as: *CIP will be the leading advocate for urban policy and community building across Canada*. With this are a series of goals including: being its members' indispensable resource for certification, professional development, knowledge exchange, and networking; being the recognized unified voice for national/federal policy positions on issues that affect urban and community planning; being the public's credible source of information concerning community planning across Canada; partnering with its Affiliates to coordinate roles and responsibilities to effectively advance the success of community planning at all levels; and being the international voice for the planning profession in Canada.

New Governance Principles

A set of governance principles was developed and endorsed. The principles provide greater clarity regarding the role of National Council, the role of its Committees, the responsibilities of individual Councilors, the relationship between National Council and its Affiliates, and the responsibilities of the Executive Director. It also includes a Conflict of Interest Policy.

CPL Infrastructure

In support of CPL (Continuous Professional Learning), the "Learning Net" feature of the redesigned CIP website has been implemented and provides an online, web-based, central clearinghouse for learning opportunities.

Planning for the Future

The ongoing MCIP (Membership Continuous Improvement Project), now called 'Planning for the Future', is nearing completion. The Competency Standards Task Force Report, the Ethical Standards Task Force Report, and the Certification Standards Task Force Report were endorsed unanimously. A fourth Task Force was struck to address accreditation standards and process. A fifth Task Force has been given the responsibility of comprehensively reviewing the FCIP (Fellow) designation/membership category and selection criteria. A Certification Standards Work Group has also been established to work on the implementation tasks outlined in the Certification Task Force Report.

Climate Change Policy Paper

A Policy Guide was developed and endorsed as a guide to preparing policy papers and position statements. The Policy Guide provided the framework for the review of the draft Climate Change Policy that was approved with revisions in June 2009.

Financial Position

CIP remains in a very positive financial position. It ended the 2008 year with a surplus of \$233,000.

The Membership Committee is responsible for reviewing all membership applications, including verifying application information submitted by candidates, reviewing Log Books and Portfolios, and administering written examinations and oral interviews for candidates for Full Membership.

In considering applications for membership, the Committee follows the requirements set forth in the Canadian Institute of Planners' (CIP) membership guidelines contained in *Schedule "A"* of *CIP By-law No. 1* and the *CIP Membership Manual*. In addition, the Committee responds to membership inquiries from members and prospective members and participates in an annual review of CIP membership guidelines and procedures with the national membership committee and membership committee representatives from all provincial affiliates.

Website

UNIVERSITY LIAISON REPORT, RICHARD MILGROM, MCIP

UMAPS (University of Manitoba Association of Planning Students) and Department of City Planning faculty presence on Council:

MPPI welcomes and facilitates the representation on MPPI Council from both the Department Head and the UMAPS chair or co-chairs and as participant in the decision-making processes. This facilitates makes for a very high level of communication between the affiliate and the planning program. Recent UMAPS representatives have been Sarah Cooper and Richard Mahé (2008/09). Current UMAPS representatives on MPPI Council are Brock Feenstra and Lacey MacLean.

Student Membership:

MPPI is supportive of the Department's orientation program for new students, helping to demonstrate the good relations between the planning profession and the planning academy to new students, from the time they enter the program. This usually results in a high level of student membership applications in most years.

Recognition of Graduates:

MPPI makes a point (at the annual 'Taking the Pulse of Practice' event - see below) of recognizing the latest graduates from the MCP program (see accompanying listing of the graduates from the 2008/09 Academic Year). MPPI members are also prominent as members of the Examining Committees (as Internal or External Examiners) for many students' Major Degree Projects (thesis or practicum). On behalf of the Department, I thank those members for their services.

Mentorships:

MPPI, through the CPL Committee, operates a mentorship program whereby students are connected with practitioners interested in mentoring them about professional career options. The annual January mentorship reception, with its 'speed mentoring' format, is becoming one of the social highlights of the year for students and mentors alike.

Internships:

Department operates an internship program for students in the summer between their first and second years. Internships are often found with the assistance of MPPI or its members in a range of practices in Manitoba.

CAPS Conference Support:

MPPI has provided support for student members of CIP attending the annual CAPS (Canadian Association of Planning Students) conference.

Taking the Pulse of Practice:

MPPI Council and its CPL Committee are active participants in the annual 'Taking the Pulse of Practice' that wraps up the Professional Practice course in the MCP program. The event features preliminary presentations of student work on their Case-in-Point collaborations with practitioners (see accompanying list of the 2009 'Case-in-Point' topics and collaborations).

It should also be noted that MPPI members often figure prominently in 'guest practitioner' presentations to the Professional Practice class, and in the closing 'praxis presentations' session. These greatly assist the students in preparing for the transition from school to work: from the academy to the profession.

Student Case-in-Point Excellence Awards:

MPPI and the Department jointly sponsor the annual Student Case-in-Point Excellence awards, now in their fifth year, with award winners featured on the MPPI web-site.

Best MDP Award:

MPPI has established an award for graduating student members, for the Best MDP (Major Degree Project) in each academic year.

CIP Academic Excellence Award:

MPPI ensures recognition - at a local event - of the annual CIP Academic Excellence Award recipient. In 2008-2009, there were two winners (with the same grade point averages): James Moore and Marcella Poirier.

Joint CPL Initiatives:

MPPI and the Department collaborate extensively to create continuing professional learning opportunities for MPPI members

Research Fellowship:

MPPI is working to establish a graduate research fellowship for the MCP students at the University of Manitoba. Some future fundraising activities will be organized to help augment the initial contribution to an endowment to fund the fellowship.

CPL COMMITTEE REPORT, NOAH YAUK

CPL Reporting

Mid term reports on CPL progress were sent out to all members in September for the 2009 reporting period. A final report will be sent out early in the New Year after year-end figures have been compiled by CIP.

Changes have been made to the online reporting system. The program is set up to display and automatically carry over eligible Learning units from the previous year.

2008:

66% full compliance
7% partial-compliance
26% non-compliance.

CPL Committee's goal is to facilitate higher full compliance rates

The Committee has developed a "CPL Reporting Learning Unit Kit" which has been made available at some of the MPPI sponsored events such as Breakfast Seminars.

The kit provides instruction on how to record learning units on the CIP website. This is part of an overall initiative to make CPL reporting easier and to encourage compliance.

The CPL Committee is giving away a prize this year, which will draw from the pool of compliant members from the last reporting year (2008). To be eligible for next years draw, members should be sure to report their required learning units on-line before the year end deadline, which is Dec. 31st.

Committee would like to see higher compliance rates for 2009 than the previous years. 2008 Compliance rates were as follows:

66% full compliance

7% partial-compliance

26% non-compliance

CPL Enforcement

For better or worse MPPI has not yet begun to discipline non-compliant members. Other affiliates are at different stages with their CPL programs—for some CPL is not mandatory (eg. Alberta, but they still log learning units). Other affiliates, such as PIBC, are much further along with their programs and take enforcement much more seriously. For example, PIBC has gone so far as revoking members who are not compliant. For MPPI, the focus has been a two pronged one: (a) to provide awareness of CPL opportunities; and (b) to make reporting easier (eg. Tutorial kit).

MPPI Student Case In Point Excellence Awards

This competition awards student/practitioner research that contributes to 'taking the pulse' of professional planning excellence. The Case-In-Point Awards committee has reviewed the 18 submissions for the 2008/2009 school year. Three of these projects will receive cash awards at this year's AGM. MPPI Council has topped up these prizes from previous years.

Mentorship

The annual Mentorship Wine and Cheese Event was held this year in February at Martha Street Studios. This event kicks-off the annual mentorship program, which attempts to match students with planning professionals to provide mentorship opportunities. Unfortunately, there were no matches made in 2009. There had been eight matches created in 2008. Only 3 students requested matches in 2009, but none of these materialized. Turnout at this year's Mentorship Wine and Cheese Event was about 30 people, which is on the low side. Students are always encouraged to become involved in this program as a good way to ease into the profession.

CPL COMMITTEE REPORT (CONTINUED)

MPPI's Presence at the MPPI Conference in Brandon

A booth was set up to promote MPPI. CPL Reporting Learning Unit Kits were made available. It was also intended for a computer to be made available so that members could log onto the CIP website and record the conference sessions they attended, rather than having to do this after the conference. For future conferences and events, the committee will strive to make a computer available for this purpose.

National CPL Committee

CPL Committee Meeting: Vancouver March 27-29

Highlights of national initiatives related to CPL include:

Membership Continuous Improvement Program (MCIP)

Through this program it is an aim of CIP to eventually make CPL reporting Mandatory at the national level. The first stage of the program would be the introduction of a standardized exam for members to achieve Full membership status. In anticipation of CPL becoming mandatory there is an effort to standardize as much as possible between affiliate CPL programs.

CPL Learning Opportunities: Online courses

On-line courses are being looked at as a valuable method of offering expanded CPL learning opportunities. The first one to be developed by CIP will come out of the CIP/NRCan Climate Change and Adaptation Program (with the intent of bringing knowledge to practicing planners). CIP is also looking also at the possibility of utilizing 3rd Party providers for on-line courses (Eg. Planetizen's on-line courses).

Annual CIP- CPL Meeting Venue

Currently, this annual face to face meeting is held every spring in Vancouver with the purpose of reporting on the progress of each affiliate CPL committee and to work on initiatives to further continuous professional learning. The CIP -CPL Committee is looking at the possibility of rotating this meeting to other cities so that the committee may increase its profile to other affiliates and also gain an understanding of the context of each affiliate. This is all for the purpose of advancing CPL. Each year this meeting would coincide to share in an affiliate sponsored social event.

CPL Reporting: Certificate of Completion

A certificate is in the process of being created to indicate that yearly requirements have been met. This would be sent to members after the end of the reporting year. This is being developed as a low cost way of acknowledging members who take CPL reporting seriously.

Development of a CPL Resource Guide for Affiliates (Cheap and Cheerful guide for LU activities)

This brochure is intended to encourage affiliates to provide robust CPL activities by providing event ideas to them. These are low cost, low tech solutions for sharing CPL opportunities.

Ethics check for online reporting

An ethics check box will be added to the CPL on-line reporting form. This places the onus on the member to agree they are reporting learning units to the greatest degree of accuracy. This check box is borrowed from AIP.

Association of Canadian University Planning Programs (ACUPP)

This group is looking at what universities are doing to facilitate CPL opportunities. This initiative is meant to strengthen the link between planning programs and the CPL committee of CIP.

STUDENT REPORT (UMAPS REPRESENTATIVE)

This year's executive for the University of Manitoba Association of Planning Students (UMAPS) consisted of two co-chairs, Sarah Cooper and Richard Mahé, the representative to the Graduate Students' Association, Becky Raddatz, the Canadian Association of Planning Students representative, Vicky Reaney, and a social coordinator, Marli Sakiyama.

UMAPS started the 2008-9 school year in July by participating in the CIP and Planners' Network conferences here in Winnipeg. We were happy to be able to co-sponsor the Alumni Reception at the CIP Conference, along with the Department of City Planning, and many students took the opportunity to volunteer and attend the conference. There were also a number of students who participated in and helped out with the Planners' Network conference, which was held the weekend after CIP2008. It was a great opportunity for us to have both these conferences taking place here in Winnipeg; it was inspiring and motivating to meet planners from all over Canada, the US, and even further afield, and to catch a glimpse of the breadth and diversity of the planning field.

In September, UMAPS took part in the orientation activities for the incoming M1 students. We also held a "welcome (back)" event for new and returning students to meet and build community within the program. Over the course of the year, UMAPS also maintained relationships with the Manitoba Professional Planners' Institute (MPPI), the Canadian Association of Planning Students (CAPS), and the Canadian Institute of Planners.

The University of Manitoba Department of City Planning made quite the showing at the 25th annual CAPS conference this year, with nine students attending and all presenting. Professor Richard Milgrom, the City Planning department head, attended as well. The Conference was held in Montréal, QC, from January 28-31, 2009. The theme was Micro to Macro, and 175 students attended to hear presentations, lectures and mobile workshops in both English and French. The conference was rich in educational and networking potential, as attendees met professionals and students from across Québec and Canada. It provided an opportunity for students to inspire each other, and to be inspired by planning ideas from different contexts, as well as by Montréal itself. UMAPS was pleased to be able to support the nine students who are attending.

In February, UMAPS held, in partnership with MPPI, a networking wine and cheese. This was an opportunity for current students to connect with professional planners and to learn more about professional life. It was also an opportunity to find a mentor through the MPPI mentorship program. A number of students and professionals attended and participated in a "speed dating" type of exercise to meet as many people as possible over the course of the evening.
