Dr. Sandeep Agrawal

Dr. Sandeep Agrawal is an Associate Dean in the Faculty of Graduate Studies and Research and a professor in the Department of Earth and Atmospheric Sciences. Dr. Agrawal is the director of the Alberta Land Institute. He was an Associate Chair in the department and Inaugural director of the School of Urban and Regional Planning between 2013 and 2023. Dr. Agrawal has a diverse array of research interests that encompasses sustainable urban and rural planning, energy transition, Indigenous issues, and human rights. As an accomplished author with over a hundred articles and professional reports and three books, Dr. Agrawal has contributed to planning practice and affected city bylaws and planning policies and legislation, with a lens on human rights and equity. The most recent book is entitled "Rights and the City: Problems, Progress and Practice." His new book "Municipal Boundary Battles" will be published soon. Dr. Agrawal is a recipient of the Canadian Institute of Planners' national academic award for his significant contribution to planning education and research in the country.

Jino joined the University of Winnipeg in1999 as a member of the Department of Geography. For over two decades, he helped guide the University of Winnipeg's Institute of Urban Studies where he worked extensively in the inner city as well as exploring broader Canadian and urban global issues. During this period, he engaged in well over 200 projects, publications and community initiatives in areas including urban revitalization, housing market analysis, urban economic development, mental health, homelessness and local and national urban policy.

At the national level, he led several multi-city projects that examined housing markets, tenancy supports, homelessness and developing a national model of neighbourhood change and distress in Canadian cities. Of note, he served as senior member of the Mental Health Commission of Canada's At Home Chez Soi project which was a \$110 million-dollar study of mental health and homelessness in five cities.

As a faculty member in the Department of Geography, Jino focuses on urban issues. He has held Adjunct Professor status in the departments of Psychiatry, Peace and Conflict Studies, Geography and City Planning at the University of Manitoba where he supports graduate students. He enjoys writing commentary and provides local and national media comment on issues relating to urban policy, poverty, transportation, inner city renewal and other civic and urban concerns.

	Politics and Planning in a Declining Downtown: Winnipeg's Story of Hope and Challenge Downtown Winnipeg has a storied but complex history that has brought decades of boosterism, planning and politics together in an often-tangled web. At one level, government funded programs have helped set a course for growth – but at what cost? As well, a plethora of booster-based agencies have offered up business incentives aimed at holding onto a faded, historic notion of what a downtown is or could be. This conversation, explores how these often competing and conflicting approaches have shaped downtown over the last 50 years and what planning in a post-pandemic downtown might look like for Winnipeg. The emphasis is a policy and program lens that focuses on how change has impacted this vibrant prairie city's downtown. Jino joined the University of Winnipeg in 1999 as a member of the Department of Geography. For over two decades, he helped guide the University of Winnipeg's Institute of Urban Studies where he worked extensively in the inner city as well as exploring broader Canadian and global urban issues.
