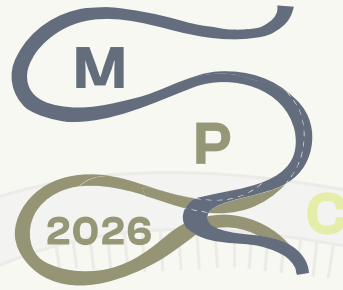

Michael Redhead Champagne

Michael Redhead Champagne is an Ininew speaker, host, author, on-screen personality and advocate for children, youth and families and is committed to systems change through love, equity and justice. Originally from Shamattawa First Nation, Michael has spent most of his life in the North End of Winnipeg and now travels to different territories sharing stories, community organizing models and published works including his first children's book "We Need Everyone", a graphic novel/creation story about him, "Little By Little: You Can Change The World", both with HighWater Press. A sought-after public speaker, event host, published author, critical thinker, systems challenger and community organizer, he has also appeared on various political panels, podcasts and television shows including APTN's First Contact & Michif Country. Michael is knowledgeable in various subject areas including youth engagement, health, child welfare, education and creating action plans. He is an avid volunteer, co-founder of Zoongizi Ode Inc, community curator for North End History, organizes the Ininimotan Language Table & hosts the annual North End Graduation Walk. Michael applies strength-based perspectives and humour to solve complicated challenges and believes that Indigenous knowledge will save the world.



Dr. Brent Roussin, MD, JD, MPH, FRCPC

Brent Roussin is Manitoba's Chief Provincial Public Health Officer and an assistant professor at the University of Manitoba. A specialist in Public Health and Preventive Medicine with formal legal training, his work focuses on population health, health equity, Indigenous health, and the application of legal and ethical frameworks to public health practice. He led Manitoba's COVID-19 response and continues to advance evidence-informed public policy across complex health systems.



Dr. Mark Seasons, Ph.D., M.Env. Des., B.A.(Hons)

Mark Seasons is a Professor and Director with the School of Planning at the University of Waterloo, which he joined in 1998. His education includes a BA (Honours-Geography) (Queen's); MEnvDes (Planning) (Calgary); and PhD (Regional Planning) (Waterloo). Mark has worked as a planner with the City of Calgary, the New Zealand federal government, the Province of Ontario, and the National Capital Commission (Ottawa-Gatineau). His research interests include plan evaluation, planning for climate change, and planning for slow-growth or declining cities. He is a Fellow, Canadian Institute of Planners, and a Registered Professional Planner (Ontario).



Dr. Enid Slack, University of Toronto

Dr. Enid Slack is the Director of the Institute on Municipal Finance and Governance (IMFG) at the School of Cities at the University of Toronto. She has written extensively on the fiscal health of cities, metropolitan governance, property taxation, intergovernmental transfers, and infrastructure finance. Enid consults with governments and international agencies such as the Inter-American Development Bank, World Bank, UN Habitat, the Forum of Federations, and the International Growth Centre. She chairs the Advisory Board of Local Public Sector Alliance (LPSA), is a member of the Advisory Board of the International Property Tax Institute (IPTI), and is an Associate of the Local Government Revenue Initiative (LoGRI). In 2012, Enid was awarded the Queen's Diamond Jubilee Medal for her work on cities.

Evan Allan is a Senior Planner with the City of Winnipeg focusing on long range planning initiatives. Evan has been practicing in the planning profession for over 10 years with experience in both the private and public sectors. Evan holds a Master of City Planning and a Bachelor of Environmental Studies (Major) from the University of Manitoba.

His specialized research focuses on climate change impacts, river hydraulics, and the anticipatory management of hydrological risks

As the Places & Community Lead at Narratives Inc., Paul guides a team that works alongside communities to honour the deep connections between people, culture, and the land. His early work as a planner explored the connections between creativity and place, which sparked a career-long focus on how a place's unique story can serve as the blueprint for its future. Paul's work seeks to go beyond the facts and figures, connecting the stories and lived experiences of people in a place to drive community planning.

Paul brings over eight years of planning experience in both the public and private sectors, ranging from municipal planning reviews to Indigenous territorial planning. He has served on the Manitoba Professional Planners Institute Board, and has spent the past three years as a member on the Canadian Institute of Planners Board of Directors.

At the heart of Paul's work is the notion that through dialogue and collaboration, people can better connect with the places they call home, which in turn leads to a better planning process. By sharing our stories of place, people become more connected to each other, to their community, and provides everyone the agency to compose a future that is not only practical but also more hopeful and connected.

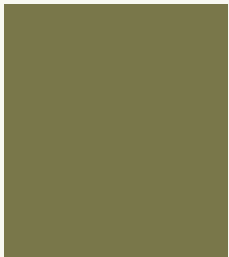
Susanne Dewey Povoledo

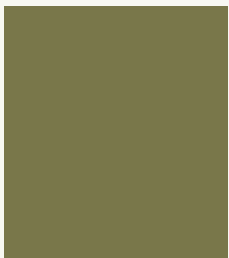
Roger Lam, MCIP, MCP (RPP)
